Le Sueur, MN/September 8, 2026 – Cambria, the leading American-made, family-owned producer of natural quartz surfaces, announces a major pricing guarantee for trade partners, ensuring zero price increases across its portfolio until at least 2028.

In an industry navigating unpredictable supply chains, rising material overhead, and cost fluctuations, this promise provides a vital anchor for builders, remodelers, interior designers, and fabricators. Volatile market pricing makes accurate project bidding, long-term budgeting, and client cost management challenging for building professionals and their clients. Cambria's guaranteed pricing model resolves this, empowering them to plan with confidence.

This unprecedented stability is made possible by Cambria's significant domestic investments. Over the past four years, the company has invested heavily in the United States, expanding its domestic manufacturing operations in Minnesota with over \$180 million in capital investments for new facilities and innovative processing equipment. This includes the installation of cutting-edge Cambria quartz processing technology at its 1-million-square-foot Le Sueur, MN, slab manufacturing facility, commissioned in the summer of 2023.

In early 2024, Cambria launched the development of its expansive quartz processing center in Randolph, MN. This \$80 million strategic project—surpassing \$260 million in total recent domestic capital investment—allowed the company to fully onshore its quartz processing to the United States. Now fully operational, this facility has not only created new American manufacturing jobs but has also spurred further investment and job growth among U.S. supply chain partners.

“As a family-owned, American-made company, taking care of our partners is always at the heart of what we do,” said Elizabeth Hurley, Cambria Chief Commercial Officer. “That means

delivering exceptional quality and service at the best possible value, and providing certainty even when the market cannot. By investing in our infrastructure and supply chain, we've created efficiencies that allow us to hold our pricing steady and pass those savings directly to our trade partners."

With this initiative, trade clients can specify and install Cambria's expansive portfolio of exclusive quartz designs for projects from kitchen countertops and backsplashes to wall cladding and fireplace surrounds, knowing that material costs are set in stone.
